## FOLLOW THESE SIMPLE STEPS TO ENSURE YOU RECEIVE DEALER SELECT CREDIT UNION “NO HEADACHES” CERTIFIED SERVICE.



The number one mistake made by vehicle purchasers is not getting pre-approved before visiting the dealership! Obtain your pre-approval and get your certificate from your loan officer before you begin. This will give you valuable information.



The second biggest mistake is not knowing who to talk with at the dealership. Make an appointment with one of the Designated Representatives listed. You may also use the internet at [www.123Car.com](http://www.123Car.com) to contact a Certified Representative. Talk only with the listed Representative to ensure you receive Credit Union “No Hassle” service. If you do not make an appointment, ask for the Rep by name when you arrive at the dealership. Refer to the attached listing, take it with you and show it to your Certified Dealer Rep.



Visit with the Representative, pick out your vehicle and test drive. Don't be afraid to ask questions. Remember this is your decision. Before you sign any documents make sure you have confirmed that this individual is a DEALER SELECT Certified Representative. Have the Certified Rep fax your completed Buyer's Order to your loan officer at the credit union and contact your loan officer for completion of your loan.
